

1. Purpose

Title XXVI of the Omnibus Budget Reconciliation Act of 1981 states under section 2604(d) (2) of the LIHEAP statute provides that the LIHEAP allocations of reservation-based Native American Tribes applying for direct federal LIHEAP funding are to be based on the ratio of the number of eligible Native American households living within a state on the Tribe's reservation or adjacent trust land, to the total number of eligible households in the state, with the resulting percentage multiplied by the state's gross LIHEAP allocation—or on a larger amount agreed on by the Tribe and the State.

The Washington State Department of Commerce (Commerce) agrees to apply to the United States Department of Health and Human Services (HHS), for LIHEAP funds allocated to the State of Washington.

The Confederated Tribes and Bands of the Yakama Nation (Yakama Nation) agrees to deliver LIHEAP services in its service area.

2. Length of Agreement

We intend the agreement to be reviewed every three years. If the agreement cannot be reviewed in this time period, the agreement will remain in effect. The agreement can be extended or renegotiated at any time with consent of both parties.

3. Service Territory

Yakama Nation shall provide benefits to all eligible Native American households residing on the:

- Yakama Nation reservation and off-reservation trust land anywhere in Washington State.
- Yakama Nation reservation and any fee lands purchased by Tribal members within the 1855 Yakama Treaty ceded area and usual and accustomed gathering areas.

For the purposes of LIHEAP, a Native American household is one in which a member is Native American. Tribal members may seek services from a non-Tribal LIHEAP servicer when the household has moved outside of the Tribe's geographical service area, if the household is closer to a non-Tribal LIHEAP provider and chooses to be served closer to home, or if the Yakama Nation runs out of LIHEAP funds.

4. Funding Allocation

Yakama Nation will receive \$840,509 from the US Department of Health and Human Services for each fiscal year of this agreement. The total Tribal distribution is based on a percentage of households with income at or below 150% of the Federal Poverty Guidelines.

5. Data sovereignty, data sharing and non-duplication of payments

Yakama Nation and Commerce will take the necessary steps to prevent duplicate payments to eligible households. Yakama Nation and Commerce will identify procedures to prevent duplicate payments to eligible households and will identify procedures to prevent duplicate payments in the separate funding plans serving separate geographic areas. In order for Commerce and Yakama Nation to prevent duplicate payments, the following is agreed to when necessary.

- A. Name and social security number of household members.
- B. Amount of assistance received in the case of persons moving on or off Tribal service territory.

Referral of applicant households will be made by Yakama Nation and Commerce when appropriate.

6. Hold Harmless

Yakama Nation holds Commerce harmless for any violations of federal regulations by the said Tribe. Yakama Nation further holds Commerce harmless for any audit exceptions of Yakama Nation administration of LIHEAP. Yakama Nation further holds Commerce harmless for any liability, loss, or damage that may be suffered directly or indirectly by any third party as the result of any claims, demands, or actions arising from the performance of this agreement by Yakama Nation.





This memorandum provides the Office of Legal Counsel's ("OLC") legal analysis of R24.271, WA Department of Commerce LIHEAP Agreement (the "Agreement") between the Yakama Nation and the Washington Department of Commerce ("Commerce"). The Agreement is to facilitate the Yakama Nation's distribution of LIHEAP funds obtained by WA to qualified households on certain Yakama Nation lands. OLC finds the Agreement *legally sufficient* as stated and qualified in the analysis below.

ANALYSIS

Finding of Minimum Legal Sufficiency:

OLC finds the attached Agreement legally sufficient as to form because it does not waive the Yakama Nation's sovereign immunity under current federal law.

Qualifications & Disclaimers:

OLC's finding of sufficiency is dependent upon the Program and Tribal Leadership's acceptance of the following unfavorable legal terms in the Agreement:

Hold Harmless: Under the Agreement the Yakama Nation agrees to hold Commerce harmless for any audit exceptions that arise in the Yakama Nation's

administration of LIHEAP, liability from third-party claims, and for any violations of federal law committed by the Yakama Nation.¹

Limitations on OLC's Review:

OLC takes no position on the below items, and respectfully defers to the Program and Tribal Leadership to determine whether or not entering into this Agreement is in the best policy interests of the Yakama Nation:

- The business terms of the Agreement;
- The truth or accuracy of any factual representations or warranties made by the Yakama Nation in the Agreement;
- The sufficiency of the vendor selection process, or Vendor's compliance with potentially applicable Yakama law, including but not limited to business licensing laws.
